Prepaid/DHMO dental¹ is a great addition for any group benefits plan. The best thing about prepaid is how easy it is for employees and their families. There isn't much they need to do or keep track of with these plans. Add to that the affordable monthly rates and low out-of-pocket costs, and you have a plan employees will really appreciate.

How are these plans different from PPO dental plans?

Prepaid/DHMO dental plans provide dental benefits according to a fixed copayment schedule. Here are some common plan features:

- No deductibles
- No claim forms²
- No annual maximum
- No referral required for Specialist benefits
- Benefits are payable for pre-existing dental conditions within the copayment schedule
- Includes cosmetic services, such as bleaching
- Additional Orthodontia and Specialist benefits are available

So how exactly does a prepaid plan work?

1. Employee will select a dentist from our network at enrollment.
2. We will add the employee to the dentist's roster as of the plan effective date.
3. Employee can contact the dentist for an appointment after the plan effective date.
4. At time of service, employee will pay their fixed copayment amount directly to their dentist.

That's it. The employee won't need to file any claims or do anything further.
